

## ALIMONY AGREEMENT IN UNCONTESTED DIVORCE

THIS AGREEMENT, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 19 \_\_\_\_, by and between \_\_\_\_\_, (hereinafter referred to as the "Husband"), and

### WITNESSETH:

1. The parties are presently Husband and Wife. They were separated on the \_\_\_\_\_ day of \_\_\_\_\_, 19 \_\_\_\_, and are presently living apart. They intend to live apart for the rest of their natural lives, and the \_\_\_\_\_ has petitioned [intends to petition] for a dissolution of the parties' marriage.
2. No children have been born of the parties' marriage.
3. The parties consider it in their best interests to settle the question of alimony, and they agree that the Court granting the dissolution of their marriage will be requested to incorporate this alimony agreement into the final decree. The parties recognize, however, that the Court on its own initiative may alter this agreement.
4. The parties agree and covenant, in consideration of the conditions contained herein, that alimony will be paid upon the following conditions:

5. The parties declare that they have both read this

agreement, that they have understood it, and that it is

legally binding upon both of them unless altered by mutual agreement or by a Court.

6. The provisions of this alimony agreement shall not be

affected by any other agreement, including a property settlement and/or separation agreement, entered into by the parties.
